## What is the survey about?

The survey is about the living and housing challenges that people may be facing. The results of the survey will be used by researchers, service providers, and government agencies to better understand the issues surrounding needs and experiences of Australians in the field of housing. Findings from the survey will be used to develop strategies to help people who face these challenges.

## How is information collected?

The Melbourne Institute and Australian Government Department of Families, Housing, Community Services and Indigenous Affairs (FaHCSIA) are working with Roy Morgan Research to collect information for this study. Some interviews will be conducted face to face while others will be on the telephone. An interviewer will contact you between 1 September and 11 November, 2012 to participate in the third wave of the survey. Interviews can be arranged at a time and place to suit you.

## Is there any payment for participating?

We greatly appreciate you taking the time to participate again in this important survey. In recognition of this, all participants will be paid \$40 each time we interview you. If interviewed in person this will be paid to you at the time of interview.

## What will I be asked to do?

If you agree to participate in this wave of the study, a face-to-face or telephone interview will be conducted at a time and location convenient to you. In this interview, you will be asked about your housing and living arrangements, education, employment, income, relationships, and health. There are also questions about living challenges that some people may have encountered, such as drug use or violence.

You are not required to answer any questions you do not wish to. The information you provide is completely confidential. Neither your answers to the survey questions nor your non-participation in the survey will impact on your Centrelink payments.

## How was I selected?

Over 1,650 people participated in the first wave of the Journeys Home survey between September and November 2011. Over 90% of participants that took part in the Journeys Home survey in the first wave also took part in the second wave between March and May 2012. We are now approaching everyone again, this time to complete the third wave of this survey. Everyone who participated in the first survey was randomly selected from Centrelink records.

## How long will it take?

The interview will take approximately 40 minutes to complete depending on your answers. You can stop the interview at any point and have the option to resume the interview at a later date.

## Is participation voluntary?

Participation in this survey is entirely voluntary and you are free to withdraw from the survey at any time. Should you wish to withdraw your data from the survey you may contact Roy Morgan Research and your information will be destroyed.

## How will my privacy be protected?

All information collected is kept strictly confidential (except where it is required to be reported by law and/or there is a risk of harm to yourself or others). Your contact details will be removed before your survey information is passed on to the researchers at the Melbourne Institute. This research is being carried out in compliance with the Privacy Act 1988 and the information will only be used for research purposes.
